
With the exception of software, the UC-PHONE-S-PLUS and UC-PHONE-T-PLUS have similar features.


Assemble the Device

Configure, Provision, and Use the Device

NOTE: (For Skype for Business phones with a user that will log in with an O365 account): Before use, the Microsoft Azure administrator must grant the desired tenant permission to log in with an O365 account. After the device is connected to the network and supplied with power, it automatically begins the initialization process. After startup, the phone must be configured and provisioned for operation.
