

GLDA-LED-JACK-CRESCODE Physical View








INSTALLATION

Before the GLDA-LED-JACK-CRESCODE can be used it must be assembled with the GLDA-LED-PROG-CRESCODE. Plug the ethernet cable from the GLDA-LED-PROG-CRESCODE into the RJ-45 port on the GLDA-LED-JACK-CRESCODE.

To connect the GLDA-LED-JACK-CRESCODE to the GLD-LED driver, insert the pins into the GLD-LED. Refer to the illustration below


